IISL Program at UN COPUOS Legal Subcommittee 1998 Session

On March 23, 1998 a Symposium "Review of the Status of the Outer Space Treaties" was held shortly after the opening of the 37th Session of the Legal Subcommittee of the UN Committee on the Peaceful Uses of Outer Space. The Symposium was organised by the International Institute of Space Law (IISL) and the European Center for Space Law (ECSL).

On request of the President of the IISL, Dr. Nandasiri Jasentuliyana, the session was coordinated by Dr. Ernst Fasan, Honorary Director of IISL, and Mr. Philip McDougall, Associate Legal Affairs Officer with the United Nations Office for Outer Space Affairs served as rapporteur.

Dr. Fasan was able to welcome the Chairman of the Legal Subcommittee, Dr. Vaclav Mikulka, and many of its distinguished delegates and guests. He introduced the speakers in the order of the agenda, namely: Dr. Stephen Doyle, Member of the Board of Directors, IISL; Mr. Andre Farand, of ECSL, who would present the paper of Dr. Gabriel Lafferanderie, Chairman of ECSL; and *Professor Dr. Lubos* Perek, of the Astronomical Institute of the Czech Academy of Sciences, and Member of the Board of Directors, IISL. As Dr. Frans von der Dunk had to excuse himself for urgent personal reasons, his paper would be read by the rapporteur, Mr. McDougall.

Dr. Fasan pointed out that the topic of the Symposium "Review of the Status of the Outer Space Treaties" was on the Legal Subcommittee Agenda for this year and he expressed the hope that the papers to be presented would informally give some background information for the distinguished audience.

After the presentation of the papers by the various speakers, there followed a "questions and answers" period, in which the distinguished delegates of Japan, Mrs. Naoko Sugita, the Czech Republic, Prof. Vladimir Kopal, Vice-President of the IISL, and the Symposium speakers participated

In conclusion, the Chairman of the Legal Subcommittee, *Dr. Vaclav Mikulka*, expressed his appreciation for the information given. He added that the problems of the status of the five space treaties and agreements were of major concern, and he thanked the IISL for the choice of this topic.

A small reception closed the event.
